1. Authority:

The event will be a Multi-Club Motorkhana conducted in the grounds of the Geelong Traffic Safety Centre held under the International Sporting Code of the FIA, the National Competition Rules (NCR) of the Confederation of Australian Motor Sport Ltd. (CAMS), the National Motorkhana Code, the CAMS Passenger in Vehicle Guidelines, these Supplementary Regulations and any Further Regulations that may be issued. The event will be conducted under and in accordance with the CAMS OH&S and Risk Management Policies, which can be found at www.cams.com.au Permit No: 316/1311/06

2. Promoter:

3. Entries

- a) Entries are open to financial members of The MG Car Club Geelong Inc. and the only invited CAMS affiliated Car Club is the MG Car Club of Victoria, who hold a CAMS Level 2NSJ, 2NS or superior licence.
- (b) CAMS Licence, Membership Card, Competition Record (if issued) and CAMS Vehicle Log Book (if issued) must be presented at time of entry.
- (c) Entries will open on 21/10 and close on 10th November. The full entry fee will be \$25 adult and \$5 for youth.

Vehicles must be adequately muffled to comply with noise restrictions.

5. Alcohol, Drugs and Substances
